WARDWATCHER

Upgrade:

- The Wardwatcher merger with Mela is still under review and we are currently asking all hospitals IT departments to ensure that they can provide the basic specifications for the new system.
- The proposed roll out date of April 2022 has been delayed while the above information is being collected.

MONTHLY REPORTS

The monthly reports now contain newly added validations regarding missing/incorrect postcodes and CHI numbers.

Postcodes:

- Please ensure that postcodes are entered for all admissions as they are important for deprivation statuses.
- If you don't know the postcode for the patient or there is no fixed abode, please enter 'XXX XXX'
Please note this is a change to previous advice of using the hospital postcode.
- Common mistakes when entering postcodes include using the letter 'o' instead of the number zero and entering the letter 'l' instead of the number 1.

CHI Numbers:

- Please enter CHI numbers for all patients (if relevant).
- If there is no CHI number, please mark 'CHI number known' as 'N' and this will grey out the CHI box.

Please continue to read and check the reports and inform us of any queries, as the reports are now sent out automatically and therefore not scrutinised as closely as before.

Many thanks again to Scottish National Audit Programme (SNAP) analyst Caroline Martin for her work in modernising the monthly reports.

MINIMUM STANDARDS AND QUALITY INDICATORS (MSQI)
