This is currently in the first phase which consists of review of the current indicators and recommendations of amendments/proposals of new indicators. We are now collating the responses received, after which, they will go for consultation to our stake holders including patient groups.

MSQI's have evolved since the first SICSAG standards and in order to drive improvement in quality of patient care we need to make the standards more measurable. Some of the recommendations will prove to be challenging to measure and this will be highlighted when we send the document out for review.
